- (1) Notwithstanding anything herein provided, in case a typhoon signal no. 8 or above is hoisted or black rainstorm warning is announced between 7 am and 3 pm on the tender closing date, the tender closing date and time will be extended to 1 pm on next working day which is not a Saturday, Sunday or Public Holiday and in respect of which no black rainstorm warning signal or typhoon signal no.8 or above is announced between 7 am and 1 pm.
